Vitamin B6, plasma (13329)

On April 4, 2022, the reference range for the Vitamin B6, plasma assay (13329/ LAB13329) will change.

Varicella zoster virus (VZV), DNA PCR (13388)

Effective March 21, 2022, LabCorp will no longer accept Cerebrospinal fluid (CSF) samples for the Varicella zoster virus (VZV), DNA PCR (13388/LAB13388) assay; the only acceptable specimens will be swabs or whole blood (EDTA or ACD).

The suggested alternative test for CSF samples is the Varicella zoster virus (VZV), cerebrospinal fluid (CSF), DNA PCR (14501/LAB14501).

Obsolete tests

Bismuth, whole blood (2558)

Effective February 28, 2022, the Bismuth, whole blood assay (2558/LAB2558), referred to MedTox Laboratories, became obsolete.

The suggested alternative test is the Bismuth, whole blood assay (994/LAB994), referred to LabCorp.

Chromium, 24-hour urine (12517)

Effective February 28, 2022, the Chromium, 24-hour urine assay (12517/LAB12517) became obsolete.
