### 2022 Antibiograms

## Specimen collection supply updates

Some of Allina Health Laboratory's previously back ordered supplies have become stabilized.

#### Metal Free Blood Collection Tubes:

Allina Health has been able to obtain an adequate supply of Navy Blue Metal Free EDTA and Tan metal free K2EDTA blood collection tubes to resume collecting metal testing in optimal metal free blood collection tubes.

• Only order what is needed for testing volumes at your site.

Refer to the AHL Test catalog for acceptable alternative tube types if needed.

#### Light Green PST Blood Collection Tubes:

Due to label placement challenges on the Roche instruments, supply chain is currently working to standardize to the 13x100 size tubes.

There is no change to ordering practices for lab staff.

If a short 13x75 is collected, ensure the label is placed as close to the cap as possible. If specimen label is not correctly placed, the instrument cannot read the barcode. See pictures below for correct and incorrect placement.



6N HCL 24-Hour Urine Collection Jugs:

Supply has stabilized for this collection container. Alternative testing alerts have been removed for 24-Hour urine testing for Catecholamines, Oxalate, and Magnesium.
